## Announcement of Change in Trade Name and Partial Amendment to Articles of Incorporation

At a Board of Directors meeting held today, Rakuten, Inc., (hereinafter “the Company”), resolved to propose a change in its trade name and a partial amendment to its Articles of Incorporation for approval at the 24<sup>th</sup> Ordinary General Meeting of Shareholders scheduled to be held on March 30, 2021, as follows.

### 1. Change in Trade Name

#### (1) Reason for Change

Since establishment of the Company in 1997, we have been developing various businesses centering on e-commerce, as well as Fintech, sports, and mobile, amongst others, in Japan and overseas. With the expansion of our business, we have grown into an organization that has acquired many group companies.

Against this background, and in light of the business environment surrounding the Rakuten Group, we aim to improve our competitiveness and agility by improving capital efficiency further, and enhancing our services with cutting edge technology, by accelerating self-sustaining growth of the Rakuten ecosystem.

#### (2) New Trade Name

In English: Rakuten Group, Inc.

In Japanese: Rakuten Group Kabushiki Kaisha

#### (3) Date of Change

April 1, 2021

\* This trade name change is subject to partial amendment of the Articles of Incorporation being approved at the 24<sup>th</sup> Ordinary General Meeting of Shareholders scheduled to be held on March 30, 2021.

### 2. Partial Amendment of Articles of Incorporation

#### (1) Reason for Amendment of Articles of Incorporation

In order to change the trade name described in 1 above, Article 1 (trade name) of the current Articles of Incorporation will be changed.

Description of Amendment to Articles of Incorporation

The details of the changes are as follows.

This supplementary provision shall be deleted after the date when the amendment to Article 1 takes effect.
